Welcome and Introductions

Mitch Burdick, Vice-Chair, called the meeting to order at 1:01 p.m. and welcomed all present. A roll call was taken and a quorum is present.

Approval of the August 07, 2023 TAC Meeting Minutes

A motion was made by Mr. Lach and seconded by Ms. Maxwell to approve the Technical Advisory Committee minutes of the August 07, 2023 meeting (included in handout). The motion carried.

TIP FY2024-2027 Modification #04 (Administrative)

This is for an HSIP project in Williamson County for Preliminary Engineering on Skyline and Crenshaw Road. This administrative action adds a program planning number to the project and does not need a vote.

TIP FY2024-2027 Modification #05 (Amendment)

This is for a new capital project utilizing CARES funds that are earmarked from Senator Durbin's office. The jurisdiction is Jackson County Mass Transit District and the project will help them update their website to include contactless payments, scheduling, fares, etc., and will include funds to cover public awareness of the new system.

A motion was made by Mitch Burdick and seconded by Mr. Phillips to approve TIP Modification #05 as presented. The motion carried unanimously.

TIP FY2024-2027 Modification #06 (Amendment)

This amendment comes from Doug Keirn at IDOT and moves the State Resurfacing project on North 6th Street from IL 149 to Dewitte Street in Murphysboro from FY2024 to FY2025 and includes cost revisions.

A motion was made by Mr. Lach and seconded by Mr. Phillips to approve TIP Modification #06 as presented. The motion carried unanimously.

TIP FY2024-2027 Modification #07 (Administrative)

This modification updates the starting location of Safety Improvements for N. Marion Street from Glade Street to Fisher Street. It is an Administrative Action and no vote is required.

Application for FY2024 SIMPO Planning Study

Mike referred to the Application included in today's handout and explained that we need to get something moving to spend more consultant funds as soon as possible. The group discussed moving forward with a Safe Routes to School Study for the entire MPO region for Private and Public Schools K-12. Recipients can be school districts or communities. Mike will be sending an email to members to get input for the scope, and urged those present to contact him with any other ideas.
